1. Adapting Services to Provide Quality Supports to **Adults with Intellectual Disabilities Affected by Dementia** 

### Nursing CEU credits have been requested for this

As providers are seeing the general age of their clientele markedly increase, concerns are growing about how to plan for and address age-associated pathologies. One such age-associated condition, Alzheimer's disease and related dementias, affects a significant number of adults with Down syndrome (over 60% of adults over 60) and a proportional number of adults with other etiologies of intellectual disability (about 6% of adults over 60). Many at-risk adults live on their own or with friends, and many affected adults live in small community group homes or with their families.

How to provide sound and responsive community care is a growing service challenge. This session provides an overview of key elements of dementia in adults with intellectual disabilities and examines strategies agencies can employ to adapt their current services to make them 'dementia capable'. Specifically covered are the elements of dementia, as well its onset, duration and effect, and techniques for adapting environments and programs. Models for supports depending on the stage of dementia are also discussed, as are training foci areas and community care models that provide for "dementia capable" supports and services.

#### 2. PATH: A Person Directed Life Plan

Tired of your typical PDP discovery tool or pre-ARD process? Do you want something that will truly motivate and empower the people you work with? PATH, Planning Alternative Tomorrows with Hope, is a person centered planning tool that has been used on an international level for over twenty years. It is considered a best practice in person directed planning and uses graphic as well as verbal facilitation to keep the process creative and allow people who cannot read to truly participate. PATH involves friends and family as well as professionals in the creation and implementation of the PATH.

### 3. An Interdisciplinary Approach to Evidence – **Based Treatment of Autism**

Interdisciplinary approaches are becoming an integral part of evidence-based service delivery in the treatment of Autism. This type of approach ensures that clinicians are able to provide an efficient and parsimonious treatment program to children and families impacted by Autism. An interdisciplinary treatment model including speech-language therapy and behavioral therapy (e.g. discrete trial training and pivotal response training) will be described and supported by outcome data, exhibiting progress in two male clients impacted by Autism. Two case studies with pre and post intervention data will be presented.

### 2. Demonstrating Success in Young Children with

ABA-SkIP is an applied behavior analysis program funded through the state of Texas Department of Assistive and Rehabilitative Services (DARS) in conjunction with the MHMRA of Harris County and University of Houston - Clear Lake. Children must be 3 to 8 years old and have a current diagnosis of a pervasive developmental disorder. The model consists of a center-based program, which children attend for approximately 15 hours per week, and parent training. The results for children completing 12 months of services will be described based on an abbreviated version of the Assessment of Basic Language and Learner Skills (ABLLS).

### 4. Teaching New Behavior

Referrals for behavior support services are often focused on reducing the frequency/intensity of undesirable behavior. Many behavioral difficulties, however, are often the result of an individual's deficits in social/coping skills (e.g., anger management skills, assertiveness skills). An individual may develop challenging behavior when compensating for these skill deficits. Addressing this often results in the development of positive behavior as an alternative to undesirable behavior. In this presentation participants will use discussion and individual/group exercises to identify skill deficits resulting in challenging behavior and develop strategies for teaching new skills and positive behaviors.

The ongoing social movement toward deinstitutionalization has compelled administrators of care facilities to rethink program efficacy measures. In this Study, the cumulative effect of stressors/mitigators on variability in subjective wellbeing were observed as allostasis and measured as decreased satisfaction. To advance the treatment, care, and community reintroduction processes, changes in quality of life were monitored. Guided and operationalized by Reiss motivators, 6 years of archival satisfaction data from institutions serving persons diagnosed with intellectual disabilities were analyzed to determine (a) subjective wellbeing via core affect and (b) latent effects of stressing/mitigating events, while controlling for individual and institutional operating parameters.
